For any cell (numerator OR denominator) less than 6, additional cells will be suppressed to disallow the calculation of the missing (suppressed) cell. Reported totals include suppressed cells.

\*\* Rate ratios were created by dividing the local area rate by the City of Toronto aggregate rate.

For gender, only male and female chlamydia cases are included. There were 25 cases reported for those whose gender is either transgender, other or unknown. Population counts are only available for males and females.

Toronto numbers are the total of all geocoded data and table excludes records with missing/incomplete/invalid postal codes.
